Shortlisting of agencies for Outdoor Sports flooring work in NISM Campus at Patalganga

National Institute of Securities Markets (NISM) invites applications for shortlisting of agencies for Outdoor Sports flooring work in NISM Campus situated at Plot No: - IS 1 & 2 and IS 4, Patalganga Industrial area, Village: Mohopada (Wasambe), Opp. HDFC Bank, Taluka- Khalapur, District- Raigad, Maharashtra, Pin code: - 410 222. The estimated cost of work is Rs. 38.35 Lakh.

NISM is a public trust, established by the Securities and Exchange Board of India (SEBI), the regulator for securities markets in India. NISM seeks to add to market quality through educational initiatives. It is an autonomous body governed by its Board of Governors.

Currently, NISM has been operating from its campus situated at Plot No: - IS 1 & 2, Patalganga Industrial area, Village: Mohopada (Wasambe), Opp. HDFC Bank, Taluka- Khalapur, District- Raigad, Maharashtra, Pin code: - 410 222 (near Panvel). The campus is having a built up area of 7.00 lakh sq. ft. on plot of lands admeasuring about 70 acres. NISM intends to shortlist eligible agencies for Outdoor Sports flooring work in the main campus situated at Plot nos. IS 1 & 2 as well as residential block situated at plot of land no. IS 4.

Eligibility Criteria

The agency fulfilling following criteria may apply:

1. The agency should have satisfactorily completed at least any of the following works during the last 7 years:
 - a. One similar work costing not less than Rs. 30.68 Lakh.
OR
 - b. Two similar works each costing not less than Rs. 19.18 Lakh.
OR
 - c. Three similar works each costing not less than Rs. 15.34 Lakh.

The period of 7 years for the purpose of having completed similar works shall be from 01.09.2015 to 31.08.2022.

2. The annual average turnover of the agency should not be less than Rs. 1.04 Crore during the last 3 years ending March 31, 2021 / March 31, 2022.
3. The agency should have GST registration.

Similar work(s) means supply and installation of sports flooring work(s).

The agency will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 3.

For the purpose, "Cost of work" shall mean gross value of completed work.

The last date of submission of applications is October 14, 2022. Application forms can be downloaded from the website <https://www.tenderwizard.com/NISM>

The interested agency must register itself on <https://www.tenderwizard.com/NISM> by paying registration fee for an amount of Rs. 2,000/- (Exclusive of GST) in order to participate in the

process. However, purchasing/applying for the shortlisting is free of cost. Class-3 Digital Signature Certificate (DSC) must be required to participate in the process.
