AMENDMENT-1

Following the correspondence received from prospective bidders and the discussion held in the pre-bid meeting on 15th June 2020 through Online Webex Session, the following amendments are issued to the RFP:

1. Section 6.1.1 of the RFP on "Experience" (on page 13) stands corrected (in red) as follows:

Bidder should have executed Web Portal and/or Mobile Application development work of following order values in the past 7 years (from June 2020)

a) Should have executed three orders each of not less than Rs.8, 40,000.

OR

b) Should have executed two orders each of not less than Rs.10, 50,000.

OF

c) Should have executed one order of value not less than Rs.16, 80,000.

The bidders must enclose copies of Purchase Orders in support of the above. Also the bidders must submit letters from the clients showing successful completion of work for each of the work orders submitted in the proposal.

2. First item in the table in Section 2.2 of Annexure-F (on page no. 35) stands corrected (in red) as follows:

#	Requirements	Description
1	Language to be used for development	Ionic with Angular JS / React JS. Appropriate plugins will be used based on the requirements.

- **3.** NISM will provide SSL Certificate and the selected bidder is responsible for installing it.
- **4.** Selected bidder will be responsible to integrate SMS and Payment Gateway provided by NISM.
- 5. Bidders who wish to submit dully filled proposals through Courier Services must send their proposals well in advance keeping in mind the last date of submission of Proposal (29th June 2020). The bidders will have to send the scanned copy of the courier receipt and tracking details by email to the contact person mentioned in section 2.6(b) in the RFP on or before the last date and time of submission of Proposals.

6. Web Portal and Mobile Application Security Audit

The Selected bidder shall carry out web portal and mobile application audit and submit a comprehensive report to NISM. This forms a part of the scope of work stated in Section 3 of the RFP. The details are as given below:

- a) The Selected Bidder is expected to engage a Cert-In empaneled Auditor to carry out the Security Audit of the website. Security Audit Certificate to be mandated along with Hash5 code.
- **b)** The mobile app security audit must be done using appropriate testing tool to identify and measure the extent of security issues. The testing tool will be arranged by the selected bidder.
- **c)** Any vulnerabilities found during the security audit must be fixed and retested until successful closure.
- **d)** The cost of the said Security Audit should be included in the cost of the Web Portal and Mobile Application.
