#### **AMENDMENTS**

Following the correspondence received from prospective bidders (by email) and discussion held in the pre-bid meeting on 12<sup>th</sup> June 2017 at NISM Bhavan regarding the above mentioned Request for Proposal (RFP), the following amendments are issued to the RFP. The bidder must submit their proposals based on the original RFP and this amendment. The two documents must be read in conjunction to ensure submission of flawless proposal.

### 1. The "Note" under clause 3.1 on "Specifications" stands amended as follows:

Note: "All Tiny/Micro form factor PCs must be of Business/Commercial series and not of Retail series. Please note that if wrong delivery is made on this aspect then Performance Bank Guarantee shall not be released and no payment shall be made for the equipment. The Laptops can be either from Business/Commercial or from Consumer Series."

#### 2. Corrections to Annexure-C on "Confirmation of Scope of Work"

The Following Corrections are made to Annexure-C:

- a. The Note written above the Table stands amended as follows:

  "Note: All Tiny/Micro form factor PCs must be of Business/Commercial series and not of Retail series. Please note that if wrong delivery is made on this aspect then Performance Bank Guarantee shall not be released and no payment shall be made for the equipment. The Laptops can be either from Business/Commercial or from Consumer Series."
- b. In Row number 2 of the Table in Annexure-C the Laptop will be either from Business/Commercial or from Consumer Series.
- c. The Row number 11 of the table in Annexure-C is amended as follows: "Confirmation regarding all PCs being from Business/Commercial series"

#### 3. Monitor Size of Laptop

The size of the Laptop screen must be between 13.1 inch to 13.3 inch inclusive of the limits. Accordingly, the screen size of the Laptop mentioned in row number 2 of the table in section 3.1 and row number 2 of the table in Annexure-C stands amended.
