## Setting the context for the webinar

Most of the listed companies had concluded their Annual General Body meetings by September 30, 2020. The general meetings had dealt with ordinary businesses like approval of accounts, dividend declarations, appointment/reappointment of directors, auditors and extra-ordinary businesses as may be warranted.

While retail investors and institutional investor would have examined the proposed resolutions only by the companies in which they would have invested, Proxy advisory firms had examined the disclosures made relating to the resolutions proposed at the general meetings by almost all listed companies as a part of their professional practice. Proxy Advisory Service companies are retained by several domestic and foreign institutional investors to advise them on the resolutions proposed by listed companies. NISM firmly believes that the observations and learnings that the Proxy Advisory entities assimilated will be very useful if shared with all the listed companies and will contribute in enhancing the quality of disclosures and resolutions.
