- In a joint submission, at least one of the authors should register and be present for the Conference.
- All the accepted extended abstracts will be published in a compendium with an ISBN number.
- The extended abstract needs to be in Times New Roman, font size of 12 and single spaced. The document has to be in Word doc format only.
