Back Ground

SEBI had issued a discussion paper in September 2020 proposing major changes to SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The above proposals were aimed at strengthening the corporate governance provisions, easing the compliance burden of the listed entities and also in harmonizing the regulations with the provisions of the Companies Act, 2013.

In addition to the above, SEBI had issued discussion papers on provisions relating to reclassification of promoters, role and responsibility of Risk Management Committee and also on the format of Business Responsibility & Sustainability Reporting (BRSR).

After taking into consideration the public comments received in this regard, SEBI has issued Notification on May 5, 2021, bringing amendments to many of the provisions stated above. These comprehensive changes to the Listing Regulations have serious implications for listed entities and therefore, it is essential for these entities to understand the rationale behind these amendments and also the manner of implementing the same.
