BACKGROUND

Financial statements are the primary document that stakeholders (including investors, lenders, customers, and suppliers) rely upon. These statements are intended and expected to depict the true nature of the business, and foretell its sustainability. A good audit and appropriate levels of disclosure are pre-requisites for reliable financial statements.

The rules and regulations formulated by Regulators require listed entities to make initial and continuous disclosures including disclosures of financials. However, in order to enable investors to make well-informed investment decisions, timely, adequate and accurate disclosure of financial results on a periodical basis is critical.
