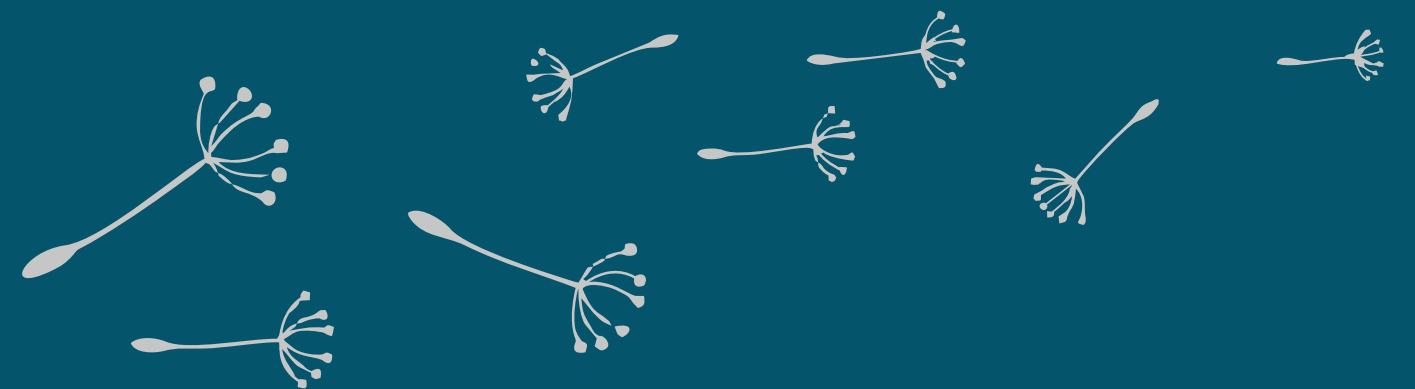

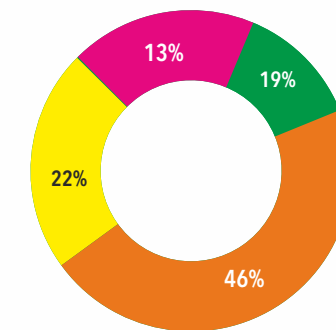
Learning-cum-Practice Programme

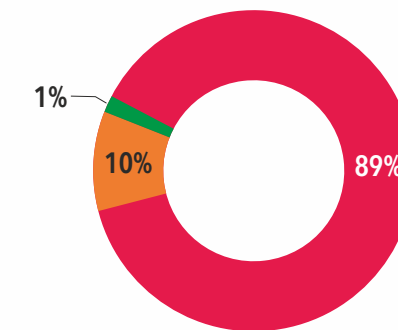
NISM is partnering with several institutions, which include market leaders, market infrastructure institutions & regulators, to achieve the same.

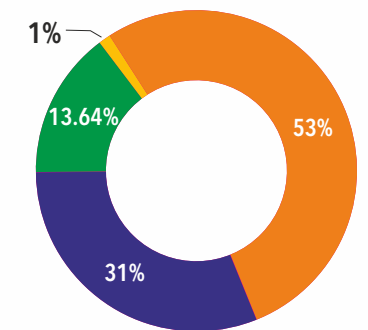

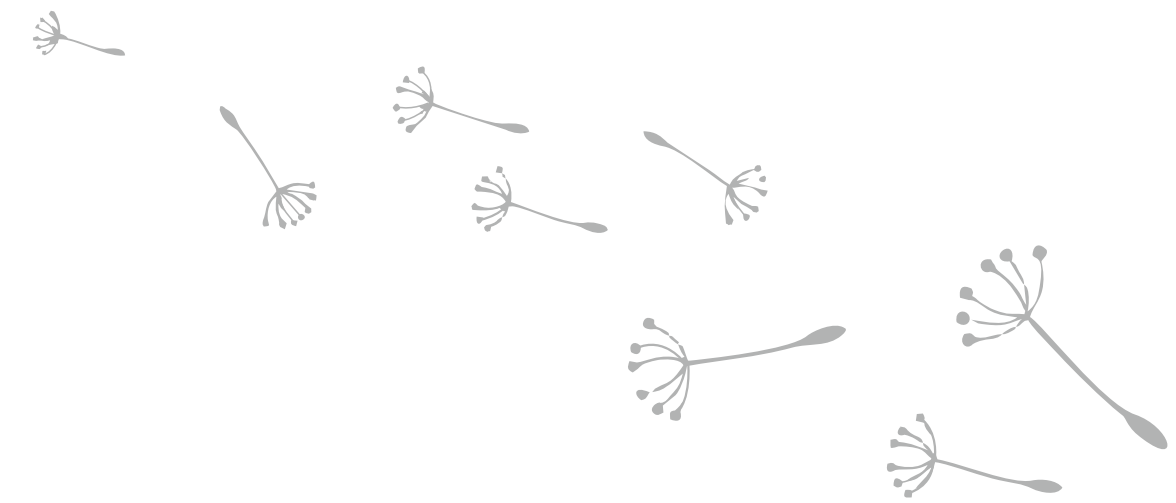
