- 2. The annual average turnover of the agency should not be less than Rs. 1.04 Crore during the last 3 years ending March 31, 2021 / March 31, 2022.
- 3. The agency should have GST registration.

Similar work(s) means supply and installation of sports flooring work(s).

The agency will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 3.

For the purpose, "Cost of work" shall mean gross value of completed work.
