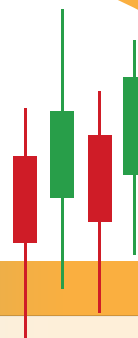

The programme is open to all undergraduate and post-graduate students from various universities, budding trading enthusiasts, investors and other participants who wish to experience the practical aspects of securities market.

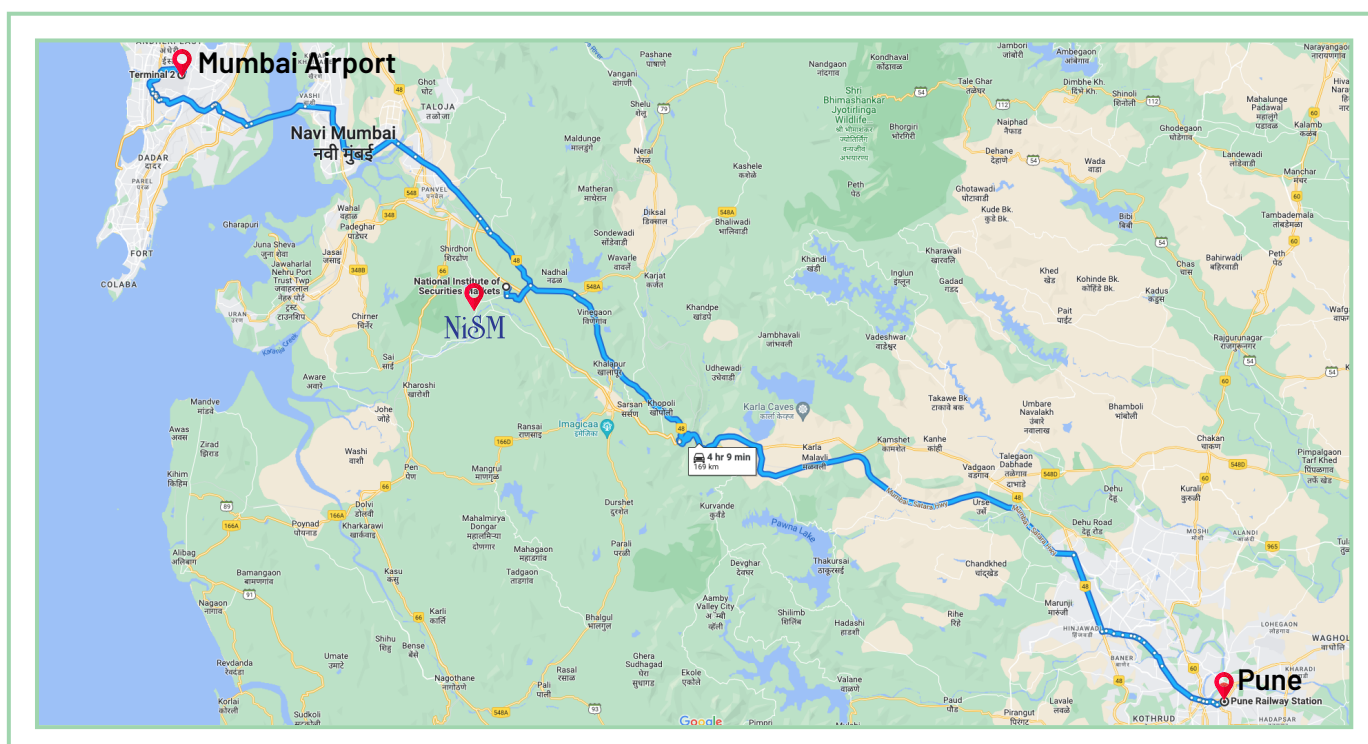
Are there any travel arrangements made for the participants?
