The period of 7 years for the purpose of having completed similar work(s) shall be from 01.06.2016 to 31.05.2023.

2. The annual average turnover of the contractor should not be less than Rs. 11,25,000/during the last 3 years ending March 31, 2022.

# 3. The contractor should have GST registration.

\* Similar work means "Execution / maintenance of electrical works".

The contractor will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 3. above.

For the purpose, "Cost of work" shall mean gross value of completed work.
