Registration & Accommodation Guidelines:

1. Read all the guidelines carefully.
2. Please keep the following points in your mind before going for the registration & accommodation:
 - a. If you want to attend Day-1 Only (13 March, 2024 at NSE, BKC, Mumbai), there is no fees for the same. Certificate of Participation will be provided at NSE, BKC, Mumbai on end of day basis.
 - b. If you want to attend both Day-1 & Day-2 (13 March, 2024 at NSE, BKC, Mumbai & 14 March, 2024 at NISM, Campus, Patalganga), You have to pay ₹1500 (inclusive of GST). Certificate of Participation will be provided. The certificate will be distributed at the campus registration desk on Day 2 of the conference, just before the valedictory session. Soft Copy/Hard Copy of Certificates will not be dispatched or sent to the participants if he/she fails to collect at the time of Valedictory Address. Conference Committee’s decision will be final in this matter.
 - c. Accommodation details form is there with Day 1 & Day 2 form. Please read the form and pay accordingly. Accommodation will be provided at NISM Campus Patalganga. *Bus facility will be provided from NISM Campus, Patalganga to NSE, BKC and return as well to the selected paper presenters and attendees who will book accommodation at NISM Campus, Patalganga.
 - d. You have to fill the details of Registration & Accommodation Charges and pay the respective fees as shown in the form. Registration is mandatory. Food is included with registration.
 - e. There are two links to fees under Registration Tab. Please select the form of “Indian Participants” or “International Participants” carefully. If you are foreign participants and want to take accommodation at NISM Campus, Patalganga, you may write a mail to ssir@nism.ac.in.
 - f. **Kindly fill up name with the right spelling. The same will be used for the participation certificate and change of name will not be entertained.** Please fill up the accommodation form if you want accommodation.
 - g. Calculate the number of **nights stay planned**. While filling up the accommodation form, you should click “plus (+)” sign to select & pay for number of days of stay accordingly. NISM will be using the Check-in date & Check-out date to cross-check the payments and accordingly provide stay facility at the campus.
 - h. **Stay is allowed at the campus from 12th March 2024 to 15th March 2024. (Maximum 3 Nights)**
 - i. There are two subcategories of payment under Accommodation Form. If you want a single room, select single occupancy as your choice. If you want to come with your spouse/parent, then after paying the registration fees for them, select double occupancy as per your choice. Female participants are not allowed to share the room with male participants for the double occupancy if the male participant is not spouse/parent or close relative.
 - j. **Selected Paper Presenters need not to pay Registration and Accommodation Charges. Please wait till the announcement of the result for your research paper.**
 - k. NISM reserves the right to cancel, postpone, modify or make any other changes related to this conference.
 - l. **The payment once made will not be refunded.**
 - m. You will get the auto-generated online receipt of the same via mail. That is the confirmation of your registration & accommodation.

3. The Details of Registration & Accommodation Fees are as follows:

Registration Fees:**

Registration Fees for Day -1 at NSE, BKC, Mumbai - ₹0

Registration Fees for Day -1 at NSE, BKC, Mumbai & Day-2 at NISM Campus, Patalganga

Registration Fees for Indian Participants – ₹1,500 (Inclusive of GST)

Registration Fees for International Participants- \$50 (Inclusive of GST)

Accommodation Charges for all Participants:

Per day Deluxe AC Room (Double Occupancy) – ₹1,650 + Applicable GST

Per day Deluxe AC Room (Single Occupancy) – ₹1,375 + Applicable GST

**Cost of Food is included with Registration Charges.

Note: Paper presenters (i.e. authors whose papers are selected for presentation at the conference) need not pay Registration charges and accommodation charges.
